

### **FCCC JOBS BOARD**

Fingal CCC have updated their website to include an interactive Jobs Board. The new <u>FCCC Jobs Board</u> facilitates the recruitment of staff into the ELC Sector in Fingal. Inform Pobal & make any necessary changes to registrations on the HIVE.

#### Service Closure if an Approved Provider closes its ELC service, or ceases to provide a DCEDIY childcare programme: Notice must be submitted in writing immediately to the local City/County Childcare Committee and the Data Management Team in the Scheme Administrator by raising a service request on the EY HIVE and selecting the Request Programme Type "User Account Management", then selecting the Category "How to" and the Sub-Category "Closures. FCCC will link in with individual services once the notification has been received.
